PROGRAM TERMS AND CONDITIONS:

- 1. Basic terms and conditions of this program are subject to the International Recognition Program (IRP) terms and conditions.*
- 2. To qualify for the rewards outlined in this program, a member must be active and in good standing and is subject to ethical business conduct.*
- 3. To achieve rank status in the IRP program, members are required to reorder certain BV in a quarter: Rank 3 – 150BV, Rank 4 or above – 250BV. NOTE! The IRP Quarter does not end as the Standard Calendar Quarter. Please check the IRP Program Calendar!*
- 4. To participate in this program, it is required to be a Platinum ranked NHT Global member and to accumulate the minimum requirement of PGV from initial orders every quarter as below:
Rank 3 & 4: must accumulate 300 BV or more in PGV from initial orders every quarter.
Rank 5 or above: must accumulate 750 BV or more in PGV from initial orders every quarter.*
- 5. NHT Global will notify winners of rewards individually by using contact information in NHT Office.*
- 6. NHT Global will not be responsible for obtaining visas and other travel documents. Qualifiers are responsible for obtaining their own valid travel documents, if needed.*
- 7. For the Luxury Car Subsidy, qualified members must submit the car model information, price and supporting documents to prove the car was purchased until March 2025. NHT Global will verify the information provided before the subsidies are rewarded. If a member meets the qualification but has previously received the Supreme Bonus Luxury Car Subsidy in any prior year, he/she cannot be rewarded again. Instead, if they qualify with 80 points, they will win an additional Trip to International destination quota to bring a family member with them. If they qualify with 100 points, they will additionally get an upgrade to an immediately superior room!*
