# INCENTIVE RULES

- I. QUALIFICATION TIME: from 00:01 on January 1st, 2025 until 23:59 on December 31st, 2025.
- II. You can qualify by reaching 1st or 2nd level during the qualification period.
- III. A Member can qualify at any one of the two levels.
- IV. Your status must be GOLD by the end of the incentive qualification period to be eligible for the NHT Global Incentive Program.
- V. You have to be ACTIVE during the entire period of the NHT Global Incentive Program.
- VI. Qualification is not replaceable and there is no possibility of obtaining alternative prize if you can not attend.
- VII. Incentive trip can be availed by only one way- by PGV.
- VIII. Each member can qualify only once for NHT Global Incentive Programs.
- IX. Qualified members may choose to participate in either the International Incentive trip to Turkey 2025 or 25th anniversary celebration trip to Hong Kong 2026.
- X. The international trip awarded under the IRP Success Exclusive Club Rewards program will be the 25th Anniversary trip to Hong Kong 2026, with year-long qualifications applicable for the trip. The qualified members will be eligible to participate in this exclusive celebration.
- XI. Qualification for NHT Global Incentive Program cannot be transferred to another person or entity.
- XII. NHT Global membership that is qualified for NHT Global Incentive Program has to be in the name of the person who qualified.
- XIII. PGV and PGV from Initial Orders used for one incentive trip cannot be reused for any other incentive.
- XIV. Only one person per NHT Global membership can qualify for NHT Global Incentive Program, for example, if a married couple shall qualify within one NHT Global membership, they will have to decide which person will attend.
- XV. NHT Global reserves the right to disqualify members from NHT Global Incentive Program, should we find out they have used any kind of unethical behavior to obtain the qualification.
- XVI. NHT Global Incentive qualifications listed above are reserved to NHT Global members for CIS, IN & JP members only.
- XVII. All accommodations provided through NHT Global Incentive Program are in a double room. Should a member insist to stay in a single room, they can do so, by paying an extra cost per a night.
- XVIII. The flight for 25th Anniversary Incentive trip to Hong Kong will be booked from the qualifier's market main city.
- XIX. Accumulated PGV throughout the year can only be used toward one incentive. Members must choose whether to allocate their PGV for the Hong Kong 25th Anniversary Celebration or one of the Turkey phases. PGV cannot be counted twice.
- XX. All expenses and applications for obtaining passports, visas, and other travel documents, including any requirements in the destination and/or stopover countries (such as vaccinations), are the sole responsibility of the qualifier.
