INCENTIVE RULES

- I. Qualification Period: From 00:01 on January 1st, 2025, until 23:59 on June 30th, 2025 (Indian Standard Time, GMT: +5:30)
- II. You can qualify by reaching 1st, 2nd, or 3rd Level during the qualification period, by achieving the Personal Group Volume (PGV) and Personal Group Volume from Initial Orders requirements, under the terms of the NHT Global Incentive Trip 2025.
- III. Your status must be GOLD by the end of the qualification period to be eligible for the NHT Global Incentive Program.
- IV. You must be ACTIVE throughout the entire qualification period of the NHT Global Incentive Program.
- V. Qualification is non-transferable to another person, and there is no possibility of receiving an alternative prize if you cannot attend.
- VI. Only PGV will be considered for qualifying for the NHT Global Incentive Program. BV from your own personal orders will not count toward qualification.
- VII. In 2025, two incentive trip qualifications overlap: the International Incentive Trip to Turkey 2025 and the 25th Anniversary Celebration Trip to Hong Kong 2026. PGV can count toward only one of the two trips. You are welcome to accumulate enough PGV points to qualify for both incentives.
- VIII. The NHT Global distributorship qualified for the NHT Global Incentive Trip 2025 must be in the name of the person who qualified.
- IX. Only one person per NHT Global membership can qualify for the NHT Global Incentive Program. For example, if a couple is married, they will qualify under one NHT Global membership and must decide which person will attend.
- X. The family member that can accompany the qualifying member on Level 3 is limited to the following: spouse, parents, siblings, or children aged 16 years or older. Any other family member will be evaluated and approved by NHT Global management.
- XI. NHT Global reserves the right to disqualify members from the NHT Global Incentive Program if they are found to have engaged in unethical behavior to obtain qualification. "Qualification" is defined as being eligible by NHT Global to earn a quota to participate in the incentive trip, even after the qualification period has ended and up until the date of the incentive trip. Any distributor who is suspended by NHT Global before the date of the incentive trip will be automatically disqualified.
- XII. This NHT Global Incentive Program is available only to NHT Global members in India.
- XIII. All accommodations provided through the NHT Global Incentive Program will be in a double room. Should a member choose to stay in a single room, they may do so by paying an additional cost per night.
- XIV. The flight provided to Level 2 and Level 3 qualifiers to the destination airport will depart from New Delhi Airport.
- XV. Level 1 Trip includes: 4 hotel nights in a double room, transport, meals, excursions, and travel insurance for the qualifier. The qualifier is responsible for their own round-trip airfare from their local airport to the international destination airport.
- XVI. Level 2 Trip includes: 1 round-trip economy class ticket from New Delhi to the destination airport, 4 hotel nights in a double room, transport, meals, excursions, and travel insurance for the qualifier.
- XVII. Level 3 Trip includes: 1 round-trip economy class ticket from New Delhi to the destination airport, 4 hotel nights in a double room, transport, meals, excursions, and travel insurance for the qualifier and one family member.
- XVIII. All expenses and applications for obtaining passports, visas, and other travel documents, including any requirements in the destination and/or stopover countries (such as vaccinations), are the sole responsibility of the qualifier.
